V. GENERAL REQUIREMENTS

- 1. Letter of application for registration directed to Director of Investment.
- 2. Photocopy of the deed of incorporation of a corporation and Registration Form issued by the Public Registry of Property and Mercantile.
- 3. Photocopy of RUC ID (Unique Registry of Taxpayer) and proof document of final registration.
- 4. Photocopy of Municipal Registration (current unexpired document).
- 5. Photocopy of general power of administration and registration form issued by the Public Registry of Property and Mercantile.
- 6. Photocopy of identity card of legal representative and/or copy of passport (for each foreigners).
- 7. Photocopy of criminal record in the country of origin (Translated into Spanish and authenticated) or Certificate of Conduct issued by INTERPOL (current unexpired document), for each shareholder.
- 8. A recent photo card of legal representative of the company and / or the Senior Shareholder of the company.
- 9. Special power of attorney, specifically for process in MIFIC. And photocopy of ID of the representative.
- 10. Is required a minimum amount for inscription of: US\$ 30,000.00 (Submit clear photocopies of invoices, receipts, mainly Deed support investment in infrastructure, purchase of supplies, buying property duly registered with the Public Registry of Property and Mercantile, vehicle fleet, professional services, office equipment, machinery and equipment, payroll, last payroll, amount others). In case, the investment exceeds US\$ 60,000.00 has to be submitted certification of investment made and signed by an Authorized Public Accountant (CPA).
- 11. Photocopy of rental agreement, signed by both parties, if the property is own of the firm submit a photocopy of the deed of sale of the property duly registered.
- 12. Photocopy Registration or permission of the institution according to economic sector (INTUR, MEM, CETREX, INPESCA, IPSA, Others).
- 13. Photocopy of the last payroll (Signed and sealed).
- 14. Investment Project Profile.
- 15. Verification visit to the business or company.

Note: <u>Each photocopy has to be certified by a public notary (according to the Notary Law of Nicaragua)</u>. If is the case, you have to submit inscriptions of these documents: buying shares, social pact's modifications and transfer of rights.
